1. ACCEPTANCE OF TERMS

By accessing, browsing, or using the SuperGrub platform (website, mobile application, or any other digital platform), or by placing an order for our products, you acknowledge that you have read, understood, and agree to be bound by these Terms and Conditions ("Terms").

IMPORTANT CHANGE: These Terms apply to all users regardless of age. There are no age restrictions for purchasing SuperGrub products, as food products are considered "necessaries" under Section 68 of the Indian Contract Act, 1872.

If you are under 18 years of age:

- Your parent/guardian may be contacted for verification in certain circumstances
- Your property (if any) may be held liable for payment of food products as per Indian law

2. DEFINITIONS

"SuperGrub" refers to the food brand operated by Dietecture Foods & Beverages LLP, a limited liability partnership registered under Indian law.

- Products not matching order specifications

7.3 Refund Process

- Claims must be reported within 24 hours of delivery
- Photographic evidence required for damage/defect claims
- Refund processing time: 7-14 working days
- Refunds will be processed to original payment method
